The table below gives details of the works which are in progress and are planned to be delivered at Sketchley Gardens. The works are also shown on the plan below.

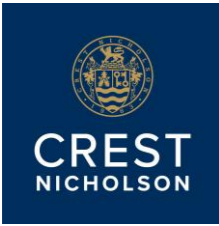

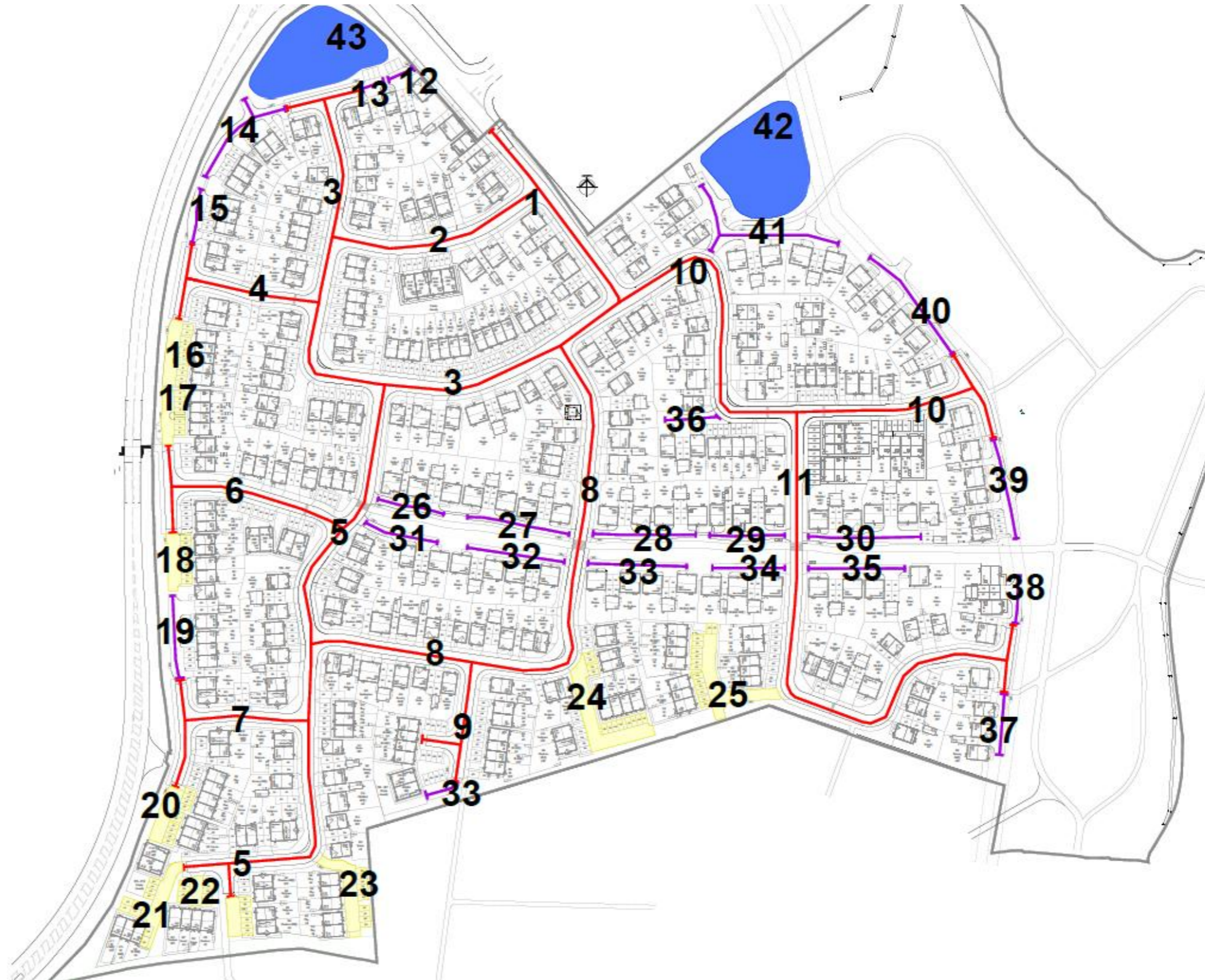

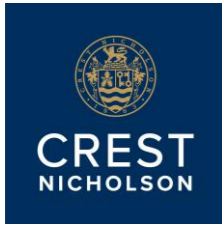
### Parcel Remaining Works Plan




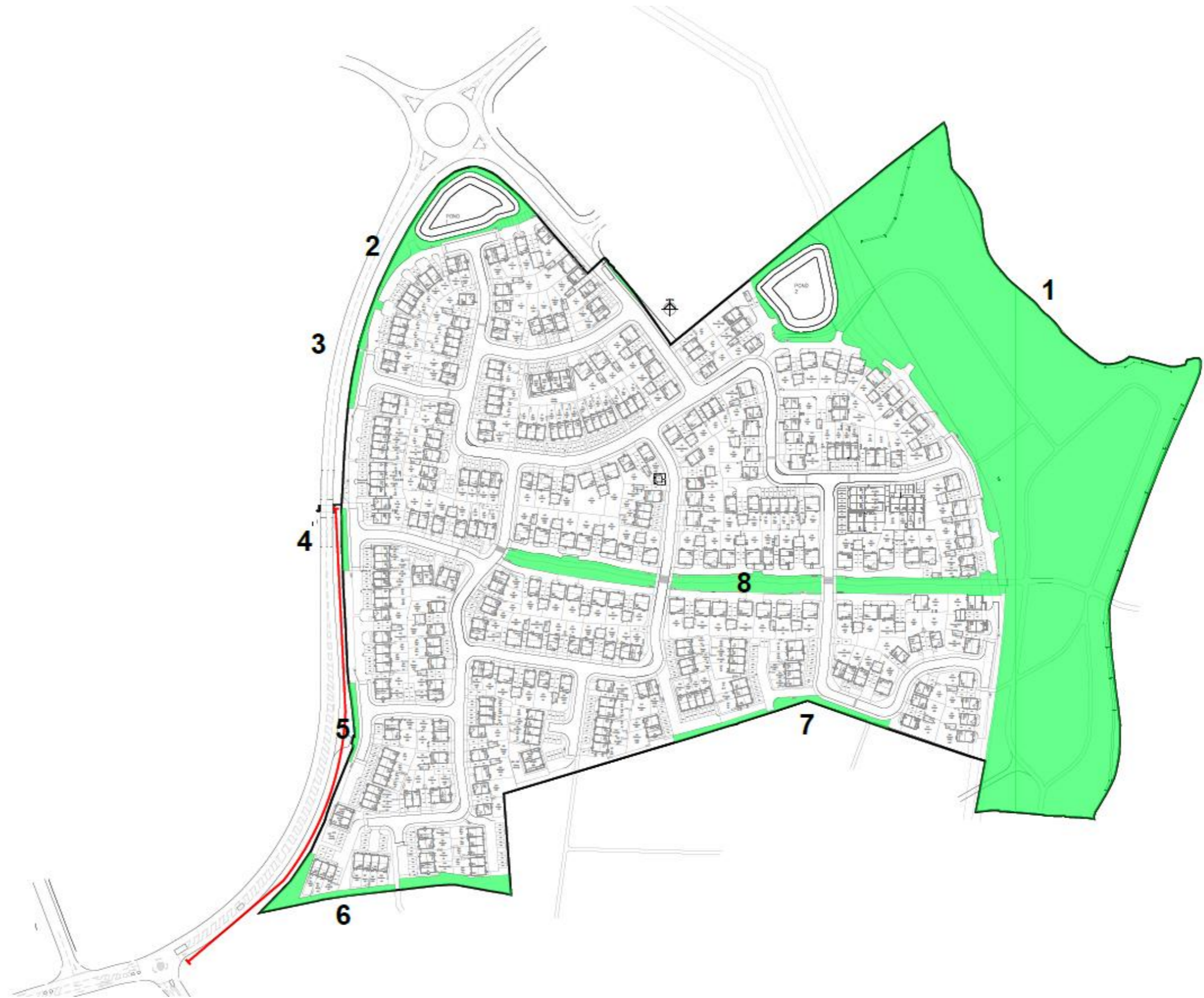

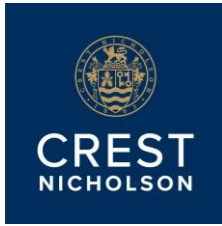
### Wider Estate Remaining Works Plan
